The undersigned (Applicant) hereby makes application to Electrical District Number Two (ED2) for electric service.

1. In consideration of ED2's providing electric service, Applicant agrees to promptly pay for such service at the regular published rates of ED2 and in accordance with the applicable rules and regulations adopted by the ED2 Board of Directors. These rules and regulations are hereby made a part of this agreement, whether effective at the time or subsequent to the execution of this agreement.

2. Applicant agrees to use such service for its own purposes and agrees not to sell or donate any part of same or permit it to be used for any other purpose. Applicant further agrees that duly authorized agents and employees of ED2 shall have access to Applicant's premises to which electric service is provided at all reasonable hours for the purpose of installation or removal of meters and equipment incidental to carrying out the purposes of this agreement and for the purpose of inspecting any electric lines or equipment in any way connected therewith.

3. Applicant further agrees to indemnify and hold ED2 harmless for claims, injuries, damages, and expenses of every nature and kind, for loss or damage to property or persons arising out of the delivery of service beyond the point of metering or for failure of ED2 to provide electric service.

4. Applicant agrees to immediately give ED2 written notice when Applicant ceases to occupy said premises or desires that service be discontinued and agrees to pay for such service until said notice is given in writing on a form provided by ED2.

5. Applicant agrees that ED2, or ED2's representative, may immediately and without any notice to Applicant discontinue service hereunder in the event of failure on the part of Applicant or Applicant's agents or employees to comply with any of the terms and conditions of this agreement. In the event of discontinuance of service by reason of such failure, Applicant forever waives and releases ED2 and with respect to anyone in or about the service premises affected by such termination, agrees to indemnify and hold ED2 harmless from any and all claims, injuries, damages, and expenses of every nature and kind that may arise out of or in any way be connected with such termination of service. Such discontinuance of service shall not constitute a waiver by ED2 of any rights or claims that it might have against Applicant as a result of having provided electric service to Applicant.

6. In the event that it becomes necessary for ED2 to employ counsel to enforce any of the provisions of this agreement or the breach thereof, Applicant agrees to pay to ED2 all costs and expenses, including reasonable attorneys' fees, expert witness fees, and costs, incurred by ED2, regardless of whether litigation is commenced. Applicant further agrees that the costs of collection for which Applicant is responsible can include a percentage fee paid to a collection agency or service, regardless whether such percentage is commensurate with the amount of work performed in collection.

7. The person signing this application avows that they are authorized to bind Applicant to a service contract with ED2.
